We are ready to welcome you back! While you have been gone our staff has been preparing to make your return as safe and enjoyable as possible. We're sure you have a lot of questions about what is to come this school year, so we've put together an area on our website with related information and our plans for returning to school this year.

Our responsibility and top priority is your health, safety and well-being. Currently, the most effective way to mitigate the spread of the Coronavirus is through social distancing and face coverings. We have focused our resources on addressing the most urgent challenges posed by COVID-19. MDTC will have color coded levels of GREEN, YELLOW, ORANGE and RED, descriptions are located on the website, indicating the procedures we will follow in response to the COVID data in our state and community. We specifically designed and customized these levels for the needs of MDTC.

- GREEN:** MDTC is open, face coverings and social distancing are recommended
- YELLOW:** MDTC is open, on campus trainings & activities are open, face coverings & social distancing are required and enforced, parents & guests are welcome and everyone must enter through MDTC's main entrance A for a required temperature check
- ORANGE:** MDTC is open, everyone must enter through MDTC's main entrance A for a required temperature check, parents are welcome, outside guests require an appointment, face coverings & social distancing are required and enforced, on campus training and activities are limited and full-time programs will implement blended learning
- RED:** MDTC is closed and all full-time programs will continue virtually

As COVID levels shift throughout the year, we will adjust our level of response accordingly. Beginning July 30th and extending through the first day(s) of school, we expect to begin the year at level YELLOW. Color coded signage will be displayed throughout the building as a reminder of the current guidelines to be followed. We will continue to keep the website updated on the current COVID-19 level for MDTC. **If a sending school closes, the students will be required to attend MDTC unless they are in quarantine or isolation.** If MDTC reaches the level of blended learning, **STUDENTS WILL BE NOTIFIED OF THEIR INDIVIDUAL SCHEDULES.**

We will work diligently to ensure that all current information is posted online to notify you of changes being made throughout the school year based on the state of our state and community. We appreciate your patience as we navigate these difficult times.

Instructional Delivery

After careful consideration, MDTC will open on August 24, 2020, providing on-site instruction for the 2020-2021 school year. MDTC will take every precaution to ensure the health, safety, and well-being of all students, faculty, and staff, as we monitor the situation and adjust our safety levels should the pandemic warrant such a response.

Class Schedules

Mid Del Tech will follow the traditional school calendar. Sessions for AM, 7:45-10:25, sessions for PM, 11:15-1:50 (high school) 11:15-2:00 (adults). Regular classes will begin August 24, 2020. Some adult programs may have a different start date. Please refer to your specific program information for details.

COVID-19 Campus Prevention Measures

FACE COVERINGS: Everyone on the MDTC campus is required to wear a mask at all times.

BUILDING ACCESS: Everyone will be required to enter the building through Main Entrance A to complete temperature checks.

HAND SANITATION: MDTC's campus has been equipped with 118 hand sanitations stations in convenient locations for everyone in the building.

BUILDING SANITATION: Restrooms are cleaned hourly and classrooms are sanitized after AM & PM sessions. Evening custodial staff will sanitize the entire facility with portable virus sprayers.

SOCIAL DISTANCING: Classrooms and shops will be set up to maximize social distancing and everyone on the MDTC campus is encouraged to follow the CDC and Oklahoma County Health Department guidelines for social distancing, which is 6 feet between everyone.

MDTC COVID Level Operations Chart

The chart is titled "MDTC COVID-19 Levels" and "MID-DEL TECHNOLOGY CENTER". It lists four levels: GREEN, YELLOW, ORANGE, and RED. Each level has a color-coded box with specific guidelines. For the safety of our students and staff, the following guidelines will be enforced for each level:
