

The Oklahoma Board of Career and Technology Education received an update of programs that will be offered by Francis Tuttle Technology Center School District No. 21 for the 2019-2020 school year. The purpose of this letter is to show approval of the programs that you will be reporting to the U.S. Department of Education for inclusion on the school's Eligibility and Certification Approval Report (ECAR).
