

The Oklahoma Board of Career and Technology Education received an update of programs that will be offered by Gordon Cooper Technology Center School District No. 5 for the 2019-2020 school year. The purpose of this letter is to show approval of the programs that you will be reporting to the U.S. Department of Education for inclusion on the school's Eligibility and Certification Approval Report (ECAR). This list indicates the programs approved for the Shawnee campus and the Aviation and Seminole sites.

The State Board approved Gordon Cooper Technology Center for continued full postsecondary accreditation on March 29, 2018. This accreditation remains valid as long as the school continues to satisfy the conditions for accreditation as established by the State Board, not to exceed a five-year period.
