
Dear Mr. Fields:

The Oklahoma Board of Career and Technology Education received an update of programs that will be offered by Tri County Technology Center School District No. 1 for the 2019-2020 school year. The purpose of this letter is to show annual approval of institutional accreditation. This list indicates program approval for the Bartlesville campus.

The goal of accreditation is to ensure that institutions of higher education meet acceptable levels of quality. Funding approval is contingent upon meeting quality standards or making satisfactory progress toward meeting those standards.

The State Board approved Tri County Technology Center for continued full postsecondary accreditation on June 25, 2015.
