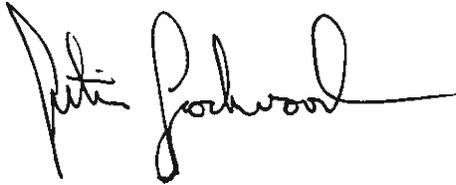

The Oklahoma Board of Career and Technology Education received an update of programs that will be offered by Western Technology Center School District No. 12 for the 2019-2020 school year.
